Instructions for Joining the Virtual Hudson CAG Meeting

Thursday May 26, 2022 | 1:00 PM – 4:00 PM

First, we appreciate everyone's willingness to join this meeting virtually. We know it will be different from a standard in-person CAG meeting, and we are working to make it as similar as possible. As in our regular CAG meetings, at this virtual meeting the presenters, CAG members, and EPA will be speaking. We will be able to see and hear them. Members of the public will be in listening and observing mode and will not be visible. Now, on to some details about how this will work:

We will be using the Zoom videoconferencing platform. If this is your first time using Zoom, you will be prompted to download a small application file. [Learn how to join any Zoom meeting here.](#)

We will be using Zoom's Webinar feature. If you are familiar with Zoom, the Webinar may look and feel a little bit different than your usual Meetings. Upon joining the webinar, please anticipate that your ability to speak and turn on your camera may be limited. These are settings that we have enabled and can adjust accordingly. We (CBI) will be managing these controls as you join. CAG members and the presenters will have the ability to be seen and heard, other participants will be able to watch the meeting, and if they have a comment or question will be able to send a note to the facilitation team.

- Please note: All webinar functions are customizable by account, so ours might not look exactly as described in this article.

A few things to optimize your participation during the meeting:

- **If possible, download/print out meeting materials in advance.** We will send materials to people who have registered in advance in DRAFT form so that you have an opportunity to set yourself up prior to joining. This is so you can follow along if you experience any tech issues.
- **If you are able, please join the meeting a few minutes before 1pm.** The webinar will be open beginning at 12:55 PM ET. This will help us orient you into the Webinar and make any last-minute adjustments.
- **If possible, please join using a computer so you can see the presentations, presenters, and CAG members.** This is especially important if you are a CAG member. Members of the public will not be visible or able to speak unless unmuted by the facilitator.
- **If you have low bandwidth, please also connect to audio via phone.** You can still join the webinar on your computer to participate on camera, but please connect your audio with the phone number listed in your registration confirmation. This means that you'll still be able to hear even if your internet connection is choppy. *Make sure to join via your computer first to take note of your participant ID number, then enter this when prompted on the phone. If this proves challenging, please email ssemine@cbi.org for guidance.*
- **For any CAG member who will just be joining by phone,** please let the facilitation team know ahead of time (by emailing ssemine@cbi.org) what number you will be calling from so we can rename your number and enable you to speak with other CAG members.
